Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security Number and driver's license number • Account balances and income • Addresses and contact information When you are no longer our client, we continue to share your information as described in this notice.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Mr. Stoner is the Manager of Direct Leased Properties, L.L.C., a private
	placement offered only to accredited investors.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	These include broker/dealers, mutual fund companies, insurance companies and other financial institutions.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	Disciplined Investors L.L.C. does not do joint marketing.
